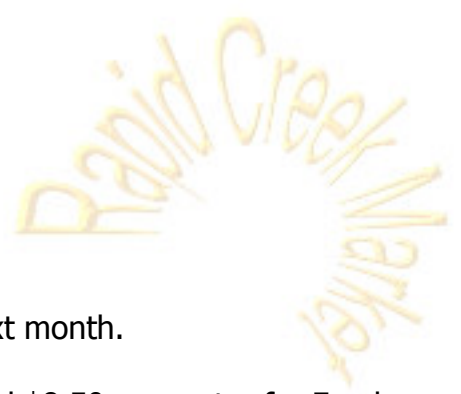

## Attention Stall holders:

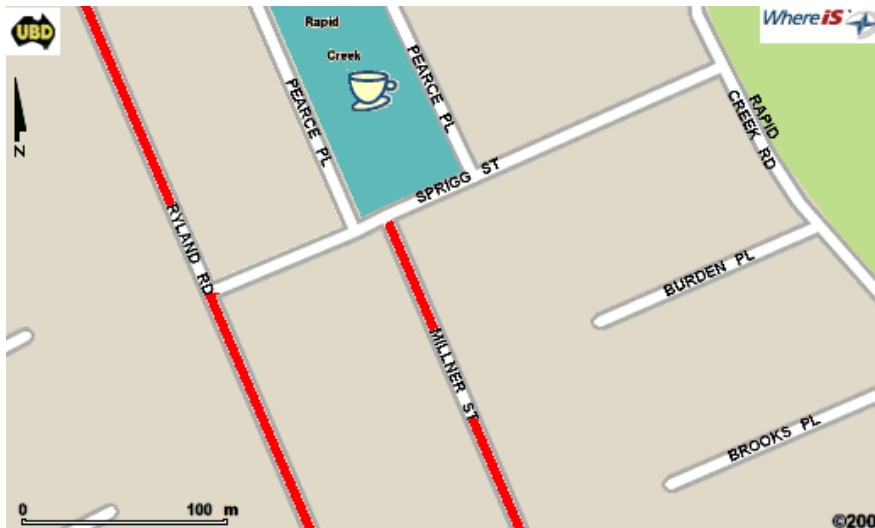
There are a number of Issues which will be addressed over the next month.

**Stall fee's:** The fee's are set at \$7.50 per metre for Craft Stalls and \$8.50 per metre for Food Stalls this will not be changing. Everyone is subject to the same price structure. Over the next few weeks stall's will be measured to ensure universal fee's. If you wish to minimise your fee's, reduce the size of your stall.

**"Dead" Space:** "Dead" space can be used to accommodate seating for the public and Buskers. This will serve to encourage greater numbers of the public to the Market. Stalls are not to obstruct walkways. Occasionally stall holder's will be requested/permitted to move stock to Vacant area's in order to fill up "dead" space. Permission need's to be obtained BEFORE doing so. And stall holders in the area are to rotate use of the "dead" space. If a stall holder wishes to regularly utilize that area, stall fee's will be payable.

**Parking:** Parking within Rapid Creek Business Village is available for the use of Customers, Tenants and Visitors to the market ONLY. Stall holders are not to park their vehicles within the complex. Stall holders are permitted to have vehicles within the complex prior to 7:30 am for the purpose of unloading ONLY. Once complete if the vehicle is not a part of the stall itself vehicles are to be removed and parked preferably On Ryland Road or Millner Street. Please ensure that Car parks are made available for customer use. Please assist each other with vehicle relocation to enable as many spaces to be available for the public as possible.

**Waste Materials:** Stalls holders are each responsible for the condition of the area surrounding and under their stall. Plant matter and other litter is to be swept up and disposed of prior to leaving, Boxes are to be removed. Waste liquids are to be disposed of properly in the gully trap in the cleaner's room. Clean oil (not containing food) can be disposed of in the oil drums in the service bay. If the drums are full notify the Co-ordinator. DO NOT over fill the drums. If ALL drums are full you are to take your oil home with you.

**DO NOT POUR WASTE LIQUIDS DOWN STORM DRAINS!!!!**

**Information sheets:** Are to be completed and returned by end of trading TODAY. The information is needed to ensure effective operation of the market and accurate planning for events. It will also assist in knowing what our market consists of to ensure effective advertising and marketing, while enabling us to keep you all up to date on developments. All new comers to the markets will be required to complete an information sheet prior to trading.

**Notice of Absence:** Written notification needs to be provided for ANY Absence, preferably 2 weeks before. Forms are available or notice can be submitted using the contact Co-ordinator form on our website but please ensure all required information is submitted. Failure to provide written notice of a prolonged absence may result in loss of position.

*If Absence is due to illness and sufficient notice cannot be given prior to the market. Call 0419834486 before 8:00am Sunday to notify that you will not be attending.*

**Christmas Craft Fair and Friday night:** As of this week there will be flyers available for distribution in regards to the Christmas Craft Fair and Friday Nights. They will be distributed with approval through Mindal Beach, Palmerston and Parap Markets. The Flyer will be available to Stall holders should they wish to assist with distribution for them to provide to friends and fellow stall holders who they believe may also be interested. The flyer will contain all relevant details and contact information.
